### Portability Out of the CHA Jurisdiction

Under certain circumstances, the Chattanooga Housing Authority will allow families to port (move) to another Housing Authority's jurisdiction and continue their rental assistance under the Section 8 Program.

#### Allowable Moves Out of the CHA Jurisdiction

#### **Applicants**

New Section 8 Program admission families who have been issued a CHA Housing Voucher but have not yet leased up in this jurisdiction, may request to port (move) out of the CHA jurisdiction to another Housing Authority's jurisdiction. Should the move be approved, the client family's Section 8 rental assistance would be provided.

#### **Participants**

Those who are already participating in the CHA Section 8 rental assistance program may request to port (move) outside the CHA's jurisdiction after they have lived in their current unit at least 12 months, if:

- the family is current on any indebtedness to the Chattanooga Housing Authority
- the family can terminate an existing lease without violating the Family Obligations document
- the annual recertification is completed

#### **Porting Out Process**

You must submit a **Request to Relocate.** If you are approved, you have to attend class before you can submit your Portability Request .

After the preliminary processes are completed, the family will be issued a temporary CHA Housing Voucher to take to their destination. It is very important that the family does not leave the CHA jurisdiction until the destination Housing Authority has notified them that their paperwork is in order and they are able to begin the process there. Your Voucher is good for **120 days**. You must have at least **90 days** left on it before it will be sent to your designated Housing Authority, **No Exceptions**. This allows the Housing Authority enough time to process your paperwork in a timely manner. There will be **No Extensions after your 120 days**. \_\_\_\_\_\_(int.)

#### Cancellation of a Request for Portability – OUT

Should a family decide that they wish to cancel their move outside the CHA jurisdiction, and they have not yet leased up in the destination jurisdiction, the family may terminate the Porting out process by notifying the designated H.A. in writing. In such a case, it is imperative that the family immediately submit a **Request for Continued Occupancy** to the CHA in order to assure that their CHA landlord agrees they can remain at their present address. If you cancel your Port and you still want to move from your current unit, you **Must Submit a RFTA here before your Voucher Expires**.\_\_\_\_\_\_(int.)
